

**MINUTES OF THE SEPTEMBER 21, 2020 MEETING  
OF THE HUMBOLDT CITY COUNCIL**

The Humboldt City Council met in regular session on Monday, September 21, 2020 in the Council Chambers of the Humboldt Municipal Building. Mayor Daniel Scholl called the meeting to order at 5:30 PM. Council Members present: Goodell, Sleiter, Dominick, and Worthington. Absent: Whittlesey.

Motion by Worthington, Second by Goodell to approve the following Consent Agenda items: 1) the agenda as printed; and 2) the minutes of the September 8, 2020 regular Council meeting. (4) Ayes, motion carried.

Ryan Miller of PeopleService, Inc. reviewed the August PeopleService reports. He updated the Council on current and upcoming repairs and maintenance issues for the water and wastewater treatment systems.

Motion by Sleiter, Second by Dominick, to approve the issuance of a Request for Proposals for an Animal Control Officer (4) Ayes, motion carried.

This being the time and place for the scheduled public hearing on the proposed plans, specifications, form of contract, and estimated cost for the City Shop Addition Project, in and for the City of Humboldt, Iowa Mayor Scholl opened the public hearing at 5:38 PM.

Nick Frederiksen of ISG was present to review the plans and specifications, form of contract, and estimated cost for the proposed street department shop addition project, which is slated to be completed by spring 2021.

The Mayor then asked the Clerk whether any written objections had been filed by any City resident or property owner to the proposed action. The Clerk advised the Mayor and the Council that no written objections had been filed. The Mayor then called for oral objections and none were made.

Whereupon, the Mayor declared the time for receiving oral and written objections to be closed. Mayor Scholl closed the public hearing at 5:40 PM.

Motion by Sleiter, Second by Worthington to approve the following proposed Resolution No. 2020-102: **“A RESOLUTION APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT AND ESTIMATED COST FOR THE CITY SHOP ADDITION PROJECT FOR THE CITY OF HUMBOLDT, IOWA.”**

Roll Call Vote: Ayes – Goodell, Sleiter, Dominick, and Worthington. Motion carried.

Motion by Goodell, Second by Sleiter to approve the following proposed Resolution No. 2020- 103: **“A RESOLUTION ACCEPTING A BID AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT DOCUMENTS FOR THE CITY SHOP ADDITION PROJECT.”**

Roll Call Vote: Ayes – Sleiter, Dominick, Worthington, and Goodell. Motion carried.

Other Items Discussed: City Administrator – Discussed the possibility of installing flashing stop signs on Taft Street North at 6<sup>th</sup> Avenue North. Also updated the Council on the status of the

Downtown Improvement Project, the 10<sup>th</sup> Street North/12<sup>th</sup> Avenue North project, and the 2020 Roadway Maintenance Project. City Clerk – Announced that the dates for burning this fall are October 17<sup>th</sup> and November 7<sup>th</sup> and 21<sup>st</sup>. Brush pick-up will be the week of October 12<sup>th</sup>. Sleiter – Asked about some manholes needing attention

Motion by Sleiter, Second by Worthington to schedule Monday, October 5, 2020 at 5:30 PM as the date and time for the next regular meeting of the Humboldt City Council and to adjourn this session at 6:15 PM. (4) Ayes, motion carried.
