

**MINUTES OF THE APRIL 5, 2021 MEETING  
OF THE HUMBOLDT CITY COUNCIL**

The Humboldt City Council met in regular session on Monday, April 5, 2021 in the Council Chambers of the Humboldt Municipal Building. Mayor Daniel Scholl called the meeting to order at 5:30 PM. Council Members present: Goodell, Sleiter, Dominick, Worthington, and Whittlesey.

Motion by Worthington, Second by Whittlesey to approve the following Consent Agenda items: 1) the agenda as printed; 2) the minutes of the March 15, 2021 regular Council meeting; 3) the February Treasurer's Report; 4) the March Treasurer's Report; 5) the March Investment Report; 6) the March claims; and 7) the renewal of a Class B Wine Permit and a Class C Liquor License for Pasquale's Italian Restaurant, Inc. (5) Ayes, motion carried.

Motion by Sleiter, Second by Worthington to accept a proposal from GDL Property Management, LTD for mosquito control services for a three-year contract commencing with the 2021 season. (4) Ayes, (1) abstention (Goodell), motion carried.

Motion by Worthington, Second by Dominick to approve the following proposed Resolution No. 2021-26: "A RESOLUTION TO ACCEPT, APPROVE, AND AGREE TO ALL TERMS OF THE AMENDED AND SUBSTITUTED INTERGOVERNMENTAL AGREEMENT WHICH CREATED THE NORTH CENTRAL IOWA REGIONAL SOLID WASTE AGENCY."

Roll Call Vote: Ayes – Goodell, Sleiter, Dominick, Worthington, and Whittlesey. Motion carried.

Motion by Goodell, Second by Worthington to approve the following proposed Resolution No. 2021-27: "A RESOLUTION APPROVING PAY ESTIMATE ORDER NO. 1 WITH BERTE & SON CONSTRUCTION OF HUMBOLDT, IOWA FOR THE CITY SHOP ADDITION PROJECT IN THE AMOUNT OF \$235,681.00."

Roll Call Vote: Ayes – Sleiter, Dominick, Worthington, Whittlesey, and Goodell. Motion carried.

Motion by Sleiter, Second by Worthington to approve the following proposed Resolution No. 2021-28: "A RESOLUTION APPROVING CONTRACT CHANGE ORDER NO. 2 WITH BERTE & SON CONSTRUCTION OF HUMBOLDT, IOWA FOR THE CITY SHOP ADDITION PROJECT IN THE AMOUNT OF A NET INCREASE IN CONTRACT PRICE OF \$1,400.00."

Roll Call Vote: Ayes – Dominick, Worthington, Whittlesey, Goodell, and Sleiter. Motion carried.

Other Items Discussed: City Administrator – Reminded the Council that nuisance mowing proposals are due on April 14. Stated that debris is being dumped illegally at the sanitation department maintenance building. Reviewed several legislative proposals from the current session. City Clerk – Announced the upcoming junk and brush cleanup dates, and the spring burn date. Stated that yard waste can be taken to the street department's brush pile area for now, until the new compost site opens. Worthington – Announced that the 7:00 AM Kiwanis Home Show will be held April 10 at the fairgrounds. Whittlesey – Asked for updates on the water main leak situation and the current roadway project. Mayor – Mentioned an alternative to city-wide junk cleanup as an option to consider in the future.

Motion by Worthington, Second by Whittlesey to schedule Monday, April 19, 2021 at 5:30 PM as the date and time for the next regular meeting of the Humboldt City Council and to adjourn this session at 5:56 PM. (5) Ayes, motion carried.
