

## MINUTES OF THE APRIL 18, 2022 MEETING OF THE HUMBOLDT CITY COUNCIL

The Humboldt City Council met in regular session on Monday, April 18, 2022 in the Council Chambers of the Humboldt Municipal Building. Mayor Daniel Scholl called the meeting to order at 5:30 PM. Council Members present: Goodell, Sleiter, Worthington, and Whittlesey. Absent: Dominick.

Motion by Whittlesey, Second by Goodell to approve the following Consent Agenda items: 1) the agenda as printed; and 2) the minutes of the April 4, 2022 regular Council meeting. (4) Ayes, motion carried.

Ryan Miller of PeopleService, Inc. reviewed the March PeopleService reports. He updated the Council on current and upcoming repairs and maintenance issues for the water and wastewater treatment systems.

Nick Frederiksen of ISG, Inc. presented an update on the status of some upcoming capital projects and other issues including the Pedestrian Bridge/Trail Extension Project, the Taft Street South sanitary sewer reconstruction, the FEMA Bank Stabilization Project, the Eagle Ridge water main loop, and the traffic signals on Highway 3 in need of replacement.

Motion by Sleiter, Second by Worthington to approve a proposal from Professional Septic Services of Humboldt, Iowa for nuisance mowing services from April 19, 2022 to December 31, 2022. (4) Ayes, motion carried.

Motion by Goodell, Second by Whittlesey to approve the following proposed Resolution No. 2022-25: "A RESOLUTION APPROVING AN AGREEMENT WITH JEFF WEISS, D/B/A WEISS SEPTIC PUMPING & HAULING OF BARNUM, IOWA FOR THE DISCHARGE OF EFFLUENT INTO THE CITY SANITARY SEWER TREATMENT SYSTEM."

Roll Call Vote: Ayes – Goodell, Sleiter, Worthington, and Whittlesey. Motion carried.

Motion by Worthington, Second by Goodell to approve the following proposed Resolution No. 2022-26: "A RESOLUTION SETTING 5:30 PM ON MONDAY, MAY 16, 2022 AS THE TIME AND DATE FOR A PUBLIC HEARING ON PROPOSED PLANS, SPECIFICATIONS, PROPOSED FORM OF CONTRACT AND ESTIMATED COST FOR RAW PUMPING AND NUTRIENT REMOVAL IMPROVEMENTS FOR WASTEWATER TREATMENT IN THE CITY OF HUMBOLDT, IOWA, AND THE TAKING OF BIDS FOR SUCH IMPROVEMENTS."

Roll Call Vote: Ayes – Sleiter, Worthington, Whittlesey, and Goodell. Motion carried.

Other Items Discussed: City Administrator – Reviewed his Administrator's Update City Clerk – Reminded the Council of the dates set junk pickup (the week of May 2). Whittlesey – Reminded the Council that a group would be removing materials from the Linhares house prior to its demolition. Sleiter – Commended Ryan Miller on the excellent job PeopleService is doing with their maintenance budget. Mayor – Reported that the digital signs will be installed when the weather improves.

Motion by Worthington, Second by Goodell to schedule Monday, May 2, 2022 at 5:30 PM as the date and time for the next regular meeting of the Humboldt City Council and adjourn this session at 6:11PM. (4) Ayes, motion carried.
