## APPLICATION FOR FENCE PERMIT

### Additional Items and Attachments

1. The applicant must complete a site plan as described on page 3.
2. The fence permit expires if work has not started within six (6) months of issuance or if the work has not been completed within two (2) years of issuance. The applicant may request one extension for no more than six (6) months.
3. The applicant is responsible for contacting Iowa One Call (811) at least forty-eight (48) hours before digging.
4. The City of Humboldt does not locate property pins, lot lines, or easements. It is the responsibility of the property owner to do so and inaccurate information on this form can result in application denial, revocation, and/or legal action.
5. If the property is located within the floodplain, the applicant must submit a Floodplain Development Permit Application in addition to the fence permit application.
6. If the property is located within the Airport Zoning Overlay, additional restrictions and height limitations may apply. The applicant must also submit an Airport Zoning Overlay permit application.
7. The fence permit fee must be paid at the time of application.
8. Your construction may be subject to additional private requirements (covenants). The City does not maintain or enforce restrictive covenants, plat requirements or deed restrictions. Property owners should check for private covenants, restrictions and other requirements before construction.

I hereby certify that I have checked and complied with all zoning regulations, flood plain regulations and airport regulations in effect at the time of application and agree to remove or bring into compliance all deficiencies at my own expense upon being notified of any non-compliance. My signature upon this application signifies that I understand that it is my responsibility to research for any restrictive covenants that may pertain to my property and that the City of Humboldt is not responsible to enforce these restrictive covenants. I also certify that the City of Humboldt is not responsible for determining the location of any lot lines or boundaries, nor does the approval of this application indicate confirmation by the City of said lot line or boundary location.




## APPLICATION FOR FENCE PERMIT

### Site Plan

Please submit below a sketch plan showing the actual shape and dimensions of the proposed fence on the lot on which the construction will take place.

1. Show streets, with street names, if any on proper sides of the lot or parcel
2. Show property lines and dimensions of the lot or parcel
3. Show locations of any existing structures, and their distances from the lot lines
4. Show locations of any existing accessory buildings (if any), and their distances from the main building and lot lines
5. Show locations of utility and other permanent easements
6. Show details of where existing fences, shrubs, buildings are on the property
